A margin was visible in the photo finish image with the actual finishing time for Zipping Cardi being 29.9035 compared to 29.9040 for Hay Riley. However, as FastTrack is limited to displaying three decimal places, both times were automatically rounded to 29.904, and as such no margin is displayed in FastTrack.
